

## **Annual Board Meeting and Election Results**

The Annual Owners Meeting was held on September 18, 2010. The Unicoi Springs staff was introduced prior to the official meeting. Each director presented a final summary in their area of responsibilty to those in attendance.

2,228 owners qualified as eligible to vote. 14 ballots were cast on the day of the meeting. A total of 880 ballots were cast. Four candi-

dates tossed their hats in the ring. The results were as follows: Mark Cook: 554 votes; Kathleen Davis: 538 votes; Bob Harber: 254 votes; Doug Shaver: 313 votes.

## Winter Projects and Upgrades

The plans and pricing are now in place for winter upgrades in the continuing effort to keep Unicoi Springs the foremost RV resort in Northeast Georgia.

Area 6 will be the main focus of the winter improvement schedule this year. Sites 275, 276, 278, 279, 280, 281, 282 and 283 will be given full facelifts including frost free faucets, 50 amp electrical service, new site lights, site enlargement, if space allows and deck repairs where necessary.

Deck repairs will continue throughout the Park. Rotted eaves will be replaced in Bath Houses 2, 3, 4 and 5.

New and more comfortable

mattresses will be purchased for the rentals. The rockers on the porch will receive new caning.

Another three-station computer desk will be built and placed on the upstairs level of the Clubhouse. The first such desk was built last year and is enjoyed by several owners. Inside and outside Clubhouse fans will be replaced, as needed.

The Upper Pool concrete deck will be resurfaced and the wooden deck and rail replaced.

The Front Entrance will be refurbished. The old railroad ties will be replaced with landscape timbers. This first

impression of the Resort has always been impressive, but now it will be even more beautiful.

Sites 56 and 57 will receive new site lights and frost free faucets. The railroad tie wall will be removed and a new retaining wall built. The wooden decks will be removed and replaced with cement decks.

Each year, when the Park closes, the building, repairs and refurbishing take center stage in anticipation of the next Spring opening and the return of the owners.

## **Gentle Reminders**

- •The new gate system only permits one vehicle to pass under the automatic arm at a time. It operates the same way that the old gate did. The arm will come down on a second vehicle.
- •Mark your "To Do" List now to make sure your golf cart liability coverage will be up to date when you return in the Spring. A few of you who have left for the season no longer have current coverage. You will want it upon your return.
- •During the winter closing of the Resort, the Office will be open from 8:00 a.m. until 5:00 p.m. Monday through Friday. The Office will be closed on the weekends during this time. Reservations for the new season starting March 1, 2011 can be made on January 2, 2011 because the Office will be closed for the holiday on January 1st. As always, reservations will be taken from 9:00 a.m. until 4:00 p.m.

- If you need to update your Christmas card list before you leave, you can check the owner address list in the Office. Phone numbers are not included due to privacy issues.
- •Your Unicoi Springs on-line store is a great place to Christmas shop. Contact the Office if you would like to have an even more personalized product prepared for you at no extra charge. Just click on the Unicoi hoodie on the home page of our website to see your store.

- •As stated in the Rules and Regulations, pets are to be on leashes no longer than 6'. Retractable leashes must be confined to 6' for the safety of owners as well as the pets.

## Winter Storage for RV's and Golf Carts

If you want to leave your camper and/or your golf cart here during the winter, space will be available to do so. Temporary winter storage will be available beginning November 15th until March 1st.

The cost for campers will be \$1.00 a day. Maintenance will be required to

move your camper in and out of the designated storage area at a total cost of \$20.00. There is a possibility that your camper will be relocated during the winter closing depending on construction projects taking place. RV storage will be determined by the Maintenance Manager.

Golf cart winter storage is also available. The cost is \$10 monthly. Golf carts will be stored at the Pavilion by the Upper Pool and will be moved as needed. Neither of these storage options includes electric.

#### **Outside Vendors and Services**

If you require the services of an outside vendor to do repairs, wash your camper or make a delivery to your site, please notify the Office of their impending arrival by signing them in the Guest book and instruct them to stop to pick up a visitor's pass. If someone is washing your camper using the Park's water, this can only be done on allowed wash days and you must check out the red bucket for them. Unicoi Springs neither endorses nor

guarantees any company you have chosen and recommends that you are prudent in your choices to assure that those services are sufficiently guaranteed and covered for your own protection.

### **Numbered Golf Cart Storage Spaces**

There is a total of 55 numbered golf cart spaces under the shed next to the Laundry and on the outside perimeters of the shed. These spaces are clearly marked and owners reserving these spaces are given the space number for their golf cart.

There have been several instances of

owners parking their golf cart in another person's space. When this happens, this golf cart and any others affected by this have to be moved and re-arranged by the staff which is both time consuming and unnecessary.

In consideration of other owners and

the Staff, we are reminding you to use the space you have contracted to use. Disregard for the storage agreement can result in the maximum fine and/or rescission of the storage space. The vacant space will then be offered to the next person on the waiting list.

#### **Correct Contact Information is Crucial**

In nearly every issue, under Gentle Reminders, we ask for updated contact information. Unfortunately, there are still many records with invalid and outdated information.

A letter is returned without a forwarding address. A call to the number in file is unsuccessful because the number is no longer in service. The worst case scenario happens when an owner has left something behind or due to a repair problem, their camper cannot be moved. There is no way to contact the owner who is traveling miles down the road, oblivious to the fact that they will need to drive all the way back to the Resort or pay someone to take care of the problem for them.

Reliable information is also crucial should an emergency arise when family at home needs to be contacted about a family member here at the Resort who cannot speak for themselves.

This is not a "gentle reminder", this is a plea to make sure that your contact information is correct. If you have a cell phone instead of a land line – we need to know. If you have a new mailing address, make sure we have it. We cannot keep you informed if we cannot reach you.

Your phone numbers will not be shared with anyone in accordance with privacy guidelines.
