In answer to the call for prospective board members to submit applications for these two openings, only two applicants stepped up. W. T. "Tommy" Walker submitted his application to run for a second term and Thurman Carpenter also threw his hat into the ring.

No one came forward to take advantage of the option of applying via petition in the time limit allowed, confirming the final number of two applicants for the election. Even though there are only two candidates for the two open positions, the By-laws

Gentle Reminders

- •Your completed election ballots must be received by September 17th at 11:00 a.m.
- •If your vehicle does not fit on your site or you need a place to park a second vehicle, you must come to the office to receive a 24-hour parking pass. If you need it for the following day, please come down to the office shortly after 9:00 a.m. to renew it. Just because a site is vacant does not mean that it has not been reserved.
- ●In deference to those who will occupy your site after you leave, and to remove temptations for bears, you are required to remove all garbage from your site.
- •If you love ice cream, you know that thanks to our wonderful volunteers, there will be at least three ice cream socials a week. Hand dipped ice cream is 75 cents a scoop. If you know you are going to partake, please try to remember to bring smaller bills just for this purpose. The office will not always have smaller change during the busy season.
- •For the benefit of all pets and pet owners, there are several centrally

located pet walks throughout the park. Each pet walk area is supplied with disposable plastic bags to assist the owners in cleaning up after their pets. Please take your pets to these areas and not to other owners' sites. In the event that an accident happens before you get to the pet area, please do the right thing and clean it up.

- •If you need to leave the park overnight and plan to return to your site, there is a green book in the office for you to document that information. You may have a maximum of 2 nights "overnight unattended" during a stay. Should you stay out an additional night, there is a \$10.00 charge. Any time beyond the three nights will cost \$50.00 per night.
- •If your camper is being stored at the Resort and you need to have repairs done on it, you must contact the office to make arrangements for it to be pulled out and placed on a site. Also, if you are selling your camper and want to make it available for someone to view, you must also contact the office and have it pulled out and put on a site. It can be unoccupied for a maximum of two nights. This procedure is for the protection of all other campers in the

storage area. Only authorized personnel are allowed in this area. If you have forgotten something in your camper, you can call the office to have someone accompany you to the storage area.

- •If you don't already know, Unicoi Springs now has WI-FI throughout the resort. A list of 13 wi-fi connection points will appear. Click on the one showing the strongest signal and you will be connected once you enter the password *unicoisprings*.
- •Nothing other than household garbage may be placed in the dumpsters at the front of the Resort. No furniture, car parts or industrial garbage is allowed. During the busy holidays, when it is evident that the disposal company is delayed, please do not add to the already overflowing containers or leave garbage outside the receptacles. Your consideration is requested to delay dumping your garbage long enough for the containers to be emptied just as you would at your own home.

Two Pet Friendly Rentals Designated

The Board passed a motion to designate two rentals - Rental #66 and Rental #231 <u>ONLY</u> as pet friendly rentals.

You may now bring your pet, with the exception of vicious breeds of dogs, as outlined in the Pet Rules, when you occupy these rentals.

For these two rentals, only, there will be an additional \$25.00 charge over and above the actual rental fee of \$50.00 per night; i.e. two nights would cost \$125.00 in total. Additional cleaning, including the washing of all bed-spreads, blankets, pillow covers and rugs is completed before the next

guests arrive. A special vacuum cleaner, designed for animal hair removal is used just for these rentals.

You are required to bring your pet's current vaccination record <u>EACH</u> <u>TIME</u> you stay. If you do not provide this information, you will not be allowed to check in with your pet.

Your pet is not to be left unattended in the rental. It goes without saying that we ask our guests to be responsible pet owners when bringing their furry family members for the benefit of the staff and those guests who will stay in the rental after you.

The remaining 16 travel trailers and 3 cabins do not allow pets. Should a pet be brought into any of the other rentals, you will be asked to leave and a fine will be levied.

Whenever owners make reservations for a rental, should one of the pet friendly rentals be reserved, the Office will always disclose that it is a pet friendly rental, should there be any allergy or health issues that would be affected by exposure to that situation.

IMPORTANT INSTRUCTIONS

Place your bid in a sealed envelope. Place THAT envelope in a second envelope, mark it BID, address it to Unicoi Springs and mail or bring it in. Upon receipt, bid envelopes will be marked with date received. Bids will be opened in the regular board meeting. Bids and bidders will be stated to members and recorded in minutes. High bid will get property.

If two equal bids, earliest postmarked date will win bid. All items shall be removed within 7 days of bid winner notification. Failure to remove property within 14 days will result in forfeiture of item to next highest bidder.

All sales are "As Is", final; no warranties or insurances shall be on said property. All bidders, buyers will be solely responsible for any required tags, titles, insurances and other needs once USCR has signed over. This shall be verified by signatures on form. Ownership will be transferred and paid for, in full, before leaving USCR property.

Bids will be opened and inspected on September 13th by the Board. Winners will be announced and notified at the Annual Owners' Meeting on September 17th.

All owners will have first choice to bid. If there are no bids, property can be offered to general public and staff. Equipment is available for inspection now. Check with the Office.

NOTE: Payment by certified funds (cashier's check, money order, credit or debit card) will be required on the golf carts. No personal checks, nor American Express will be accepted.
