If you shrink down or cancel the original reservation for any reason, that fee will not change; you will still be responsible for the original fee regardless of the reason for cancellation.

If you add days to your reservation, the fees will be added according to that increase in days.

Your current Rules and Regulations will contain this procedure as well.

Gentle Reminders

- Should you need contact information on your Board Members, please come in or call the Office. This information, nor the financial reports are published on the Unicoi Springs website since it is open to the public; however, it is available to owners in the Office.
- ♦ When you sign in on a new site, it is imperative that any and all fees are paid at that same time. Timely signing in and payment keeps the system running smoothly. Sending invoices costs extra money, time and materials. Remember to bring your checkbook if you want to avoid the 3.5% convenience fee for using credit or debit cards.
- ♦ At least one of your U numbers must be displayed on any golf cart or any towing apparatus brought into the Resort other than your RV. If you have a cover, the number must also appear on that. The reason for this ruling is so the owner can be contacted if the vehicle or utility trailer

- needs to be moved when there is a problem with the location of the vehicle or trailer.
- ♦ Only one car or truck may be parked on your reserved site with the exception of holiday weekends when parking permits are not available. During these times, two cars may be parked on your reserved site as long as they are not on the grass or impeding traffic. You will see a notice in the Clubhouse notifying you of this permission. All other times, if you need additional parking, please come to the Office for a 24-hour pass on a vacant site. Remember, just because a site is empty, there is a possibility of someone arriving later in the day. The Office or Security is the only source of that information.
- ♦ If you are a new owner, please pick up a current copy of the Rules and Regulations to familiarize yourself with important procedures at the Resort. If you have any questions in this regard, please do not hesitate to

- ask in the Office. The Rules and Regulations are also on the Unicoi Springs website so you can view them there or download to your devices. This is also a good idea if you are not a new owner. Each time modifications have been made, the Rules will be reprinted with a new effective date, so check periodically to make sure you have the most up to date version.
- ♦ Do you know if your LP tanks have been inspected and certified? The first time they are inspected, they are good for ten years, but they have to be recertified every five years after that. Our maintenance staff are not allowed to fill them if the certification date has expired. With cold weather arriving, be sure to check your tanks so there are no surprises for the upcoming cold days.

We Need Your Help With Covenants

The first Town Hall Meeting was held on October 25th to discuss the Revised Covenants. There were 58 owners in attendance.

Our current USCR Covenants were written by the resort developer in 1983. Other than a few amendments written in the next couple of years, nothing has been updated since.

The Covenants need to be revised to update and include things that we are currently doing at the Resort, i.e., days out and storage.

The Revised Covenants are on our USCR website in the Document Library. It will take 2/3rds vote or 2,000

out of 3,000 ownership votes to pass the New Covenants.

At the meeting, definitions were discussed with owners' input of suggestions. There was a question-answer session at the end. Additional Town Hall Meetings will be held next Spring and Summer, probably on Saturdays.

We cannot predict when the Revised Covenants will be ready for a vote as we still need to hear from you, the owners, and various points from our attorney. There is a lot more to be done with more revisions as we get more answers and suggestions.

Upon receipt of the email, an automated response will advise that the email has been received and you will be contacted when we discuss that issue.
