#### Acclamation

#### **Unanimous Consent**

I David F. Stover, Unicoi Springs Camp Resort President make a motion to declare the 2019 Board of Directors Election to be resolved by the Acclamation process.

Roberts Rules of Order, if there is not opposition there is no need for a formal vote; the matter is decided by "acclamation" or by "Unanimous Consent"

Per Article III, Part A, Section 7 and 8 of the Bylaws of Unicoi Springs Owners Association, Inc. ("Association"), as amended, the Nomination Process for election to the Board of Directors requires the Board to nominate "any number of qualified individuals, but not less than the number of director to be elected." Additionally, any other Owners wishing to be nominated for election to the Board can submit a written petition (signed by at least 75 Owners) nominating the Owners directly. Nominations are NOT required to be allowed to be made from the floor at the annual meeting. All Owners in the Association have been given an opportunity to nominate themselves or someone else by a posted/published deadline, and if that deadline has passed, and if only TWO (2) people have been nominated for TWO (2) open positions, then the Association should NOT be forced to send out ballots to all 3,000 members of the community. Rather, a letter should be sent to the Owners with the Notice of Annual Meeting stating that the Association only received two (2) nominations to fill the two (2) Board positions on the Board of Directors, and since these positions are uncontested than these two (2) nominees Thurman Carpenter and Rebecca "Becky" Manley will automatically be elected by acclamation (i.e. unanimous consent).
