The bank balance in investment account is \$274,614.09 as of February 29,2020. We transferred 200,000 into payroll and operations.

The bank balance in Payroll is \$21,078.33. \$40, 000 of transfer was to payroll.

The bank balance in the Operations account is \$14,216.81 and \$160,000 too transfer was to this account.

\$100,000 was transferred out of Operations to Southern Bank & Trust. We earned \$40.67 YTD with a balance of \$157,235.06.

Rabun County Bank has a balance of \$77,428.04. This is the camper/vehicle replacement fund.
