Winter Projects

Areas 2 and 6 closed on November 15th to facilitate winter work projects. Areas 3 and 4 closed on January 2, 2019 with the exception of Sites 110-118 and the tent area.

All of Areas 3 and 4 reopened March 4, 2019. Areas 2 and 6 will re-open on April 1, 2019.

Sites 282, 284, 286, 288 and 290 have been rebuilt and given new pads and decks. These sites are already 50-amp sites. Completion of the project for this past winter is paving of Area 6. This should be done by the time the area reopens April 1, 2019 if the weather holds.

Our Housekeeping team continued their normal winter schedule of deep cleaning every bathhouse, each and

every rental, the Activity Building and the Clubhouse. We ask for understanding of the owners staying here during the winter months in the necessary closing of the larger areas. The deep cleaning involves extreme removal of items and detailed floor to ceiling cleaning in addition to applying wax to the floors of the Activity Building and the Clubhouse. 

Gentle Reminders

•Ouestions regarding rules, policies, fees, etc. should be addressed to the Board of Directors or the Office. Posting these inquiries on the Yahoo **Group or the Unicoi Springs Facebook** page may not garner the correct answer or possibly no response at all. These two social media sites are NOT **OFFICIAL Unicoi Springs sites and** are not monitored by the Board. They have been created by volunteer owners to encourage conversation and enjoyment among owners.

Sometimes, a simple phone call can clarify an issue. If you wish to have a formal answer from the Board of Directors, a letter, including your

name and owner number can be submitted to the Board. These letters will be addressed at the next meeting and you will receive a written reply.

If your issue is important enough to you, you may request to appear and speak to the Board as long as you contact them, in writing, 10 days prior to the next Board Meeting.

◆Please place your "U" number on the tongue of your tow trailer. Thanks to all who have done so. Please park in

the designated areas or at the end of the Chapel parking lot for possible removal by the staff to the trailer storage area during busy times.

•If you notice something that needs attention or repair, please notify the Office so immediate action or a work order can be prepared, documented and assigned to the proper department.

•On October 1, 2008, the first official test of the our severe weather siren system was implemented. Monthly tests have continued on the first Wednesday of each month on clear days. Listen, and you will hear the recording assuring you that this is a test. The test will be rescheduled if the normal test day is not a clear day. This system enhances the security our owners have experienced over the years.

◆It is your responsibility, as an owner to stay apprised of current Rules and Regulations. Printed copies are available in the Office and are also available for viewing and/or printing in the Unicoi Springs website Document

Library.

•We encourage all owners to use Oxi-Clean in laundry and Rid-X in holding tanks in place of Clorox. Both of these products are better for our sewer system, which is like a home septic tank.

•The GPS coordinates of the Resort are posted on the website as well as print advertising and collateral pieces as they are replenished. Many people are not aware that the GPS system does not recognize Unicoi Springs Camp Resort address as Helen. Sautee Nacoochee, 30571 must be entered as the address to get the most direct route. Otherwise, it will send them down Bean Creek Road which is not an easy route for a big rig.

As in the past, the first portion of your \$450.00 maintenance fees were due January 1, 2019 and the remaining half is due April 1, 2019. If at least the first portion is not paid by February 1, interest charges of 1.5% are charged on that first portion until it is paid. If

you still have a balance on May 1, 2019, interest will be charged monthly on the entire past due balance. Reservations may not be made until your account and any linked to your are current.

We ask that you pay your fees in a timely manner or contact the Office if you are experiencing financial difficulties.

You will have to take your tanks to a certified LP company where they will check for leaks, make sure you have the proper valve and that your tank is safe. If your valve needs to be replaced, the consensus is that buying a new tank is the most economical route.

Once your tank has been re-certified. vou are required to have them checked and certified again every 5 years. Stickers will be affixed with this inforThere are three companies in our area who can re-certify your tanks:

Blossman Gas - 706-865-1797. They charge \$15.00.

GA Mountain Gas - 706-348-2020. They charge \$5.00.

Amerigas – 706-865-2131. Their charge is \$19.95 and will not be resuming that service again until the summer.
