- II. Reviewed Payable Receipts

- The Bank Balance In Investments Account Is \$644,554.32 As Of April 30, 2022. We Transferred \$70,000.00 Into Operations And Payroll. The Bank Balance In Payroll Is \$28,841.61 And \$40,000.00 Was Transferred Into Account
- IV. The Bank Balance In The Operations Account Is \$23,431.88 and \$30,000.00 Was Transferred Into Account
- V. Pinnacle Bank (formerly Southern Bank and Trust) A Balance Of \$157,883.26. (earned \$31.14 YTD)
- VI. Rabun County Bank With A Balance Of \$79,862.33 This Is The Camper/Vehicle Replacement Fund.
- VII. The Bank Balance In The Bathhouse Fund Is \$103,532.00
- VIII. The Bank Balance in The Road Improvement Fund is \$71,482.00
- IX. We Have (3) \$100,000.00 CDs

#### **Updates: Thurman Carpenter**

- \*Contract Has Been Accepted For Renovations On Bathhouses 1 and 5, Waiting And Material Delay For Shower Stall Walls And Will Begin Just As Soon As Possible
- \*Culvert Pipe Project By Chapel Will Have The Road Torn-Up For A Few Dates, So Traffic Will Have To Be Routed To The Right Around It. We Are Hoping This Will Be Completed In June.
- \*Maintenance Has Finally Gotten Caught Up Enough To Start With Heavy Weed Eating And Grounds, Things Are Looking Good and the Guys Work Hard So If You See Them Give Them A Big Thanks.

#### **New Business: Randy Frame**

- \*We Are Still Waiting For Refund From Previous Insurance Company So Financials Will Look A Little Different After That Is Refunded. We Did Switch Insurance Carriers At End Of 1st Quarter So Once The Final Audits Are Complete We Will Be Receiving Those Monies Back, Hopefully By End Of June.
- \*New "Point Of Sale" System Contract Was Awarded To FIneTech And With Getting This Set And In Place We Will Be Updating Our QuickBooks In The Office As We Are About 6 Years Behind. This System Sync Directly With Quickbooks SO When You Pay Any Of Your Bills It Will Post Directly To Your Account So This Should Rectify The Issues Of Pay Bills And Still Receiving Bills Stating It Was Not Paid. It Will Print Receipt On The Spot With All Line Items Paid Shown On Same Receipt.
- \*This Will Print Daily Reconciliation Reports For Deposits and Will Be Taken To The Bank Same Day.
- \*Voted To Change Charge Card Processing Company, Will Be Saving Approx \$1,700.00 Per Month, Projected 1st Year Savings Of \$21,000.00 and 3 Year Savings Of Around \$64,000.00. (these are projections not hard numbers as we used this YTD charges to calculate and this varies)
- \*Approved The Online Reservation System, This Will Be A Few Months Out As The Program Has To BE Written To Meet Our Needs At This Park. You May Find Times That You Will Need To Still Call The Office And Of Course You Do Not Have To Use It And Can Continue To Make Reservation As You Have Been. Once It Is Up And Running You Will Be Able To Book, Pay And Check-In All Online. Once This is Ready To Go Live And If There Is Interest We Will Be Happy To Hold A "How To" Session or Two.

- \*We Will Be Installing A Commercial Grade Garage Door Opener In Maintenance, Once This Is Installed The Shop Will BE Closed And Locked At All Times.
- \* Blossman Gas Is To Come Out And Set-Up Filling Station So We Can Hook Up Generator So When Power Go Out We Can Still Fill Propane, We Can Not Pump Gas When Power Is Out Now. We Are Also Looking To Setup The Front Office On Generator Also.
- \*Approved E-Bikes And Keeping With Georgia Law You Must Be 15years Or Older And Everyone Must Wear Helmet and Follow All Road Speed Limit, Stop Signs, And Directional Signage In The Park.
