Randy Frame - Open Floor For Questions:

*Reminder- We Will Deal With And Limit You To Two Questions Per Owner, With Three Questions Per Subject. You Have Two Minutes To Ask Your Question, If At That Time You Have A Second Question You Can Ask It Once It Has Circled Back Around. All Question Should Be Ask To The Board, All General Discussion Among Owners Can Be Done Outside After the Meeting.

Question: What Are the Rules And Regulations For Becoming A Board Member?

Answer: There Is A List Of Requirements In The By-Laws / Real Quick Off The Top Of My Head, Owner For 3 Years, Be In Good Standings, No Fines Within A Certain Time Frame And Volunteer Hours With Sanctioned Park Events. You Are Welcome To Pick Up A Copy Of By-Laws In The Office.

Rebuttal: I Have Already Done My Investigation And There Is A Board Member Who Is Not A Member Of This Park

Answer: That Is Not True, We Can Address That At A Later Time But We Are Not Going To Get Into It At This Time

Question: I Don't Want To Pay 4% More Or Pay Be ACH Check When Making Reservations I Am Not Comfortable Giving Out This Information Because Of Scamming Or The Office May Write It Down My Banck Account Information And Keep It. Do You Not Trust Owners To Pay?

Answer: Anything Stored in The Computer Is Only Done So By The Last (4) Digits. If You Write A Check The Office Has All Your Information Also So I am Not Understanding The Difference On The ACH With Account And Routing Number. You Would Be Very Surprised Just How Big The Collection Folder Is That The Office Has To Call On Daily To Collect Monies. The People DO Not Pay While They Are Here. Once The Online Systems Goes Live You Will Be Entering your Own Information And Have The Option On Saving It Or Not. Or You Can Mail A Check In And Once It Has Arrived you Can Call To Make Reservations. If Any OF You Travel You Know That This Is The Way Of The Industry Both In RVing And Even Hotels.

Question: I heard About Background Checks On New Owners and Only New Owners And Would Like TO Know What We Have Found Out.

Answer: Yes This Was Brought Up A Year Ago At The Owners Meeting And Since Then We Have

Been Talking With Lawyers And Have Brought It Up At 2 Other Meetings With Solely Positive Feed Back. We Are In The Outline Process Of This, But To Highlight On The Private Market The Seller Or The Buyer Would Have To Contact The Background Check Company, Pay The Fees For Their Background To Be Checked. Then The Background Company Would Confirm With The Office. No One Here Would Ever See A Background Unless Someone Would Like To Appeal It. This would be For Felonies And In The Events Over The Past Couple Weeks Where Felons Are More And More Hiding Out In Campgrounds. Once Again This Is For Felonies, Sexual Assaults, Violent Crimes, And The Even Includes White Collar Crimes. So If You Knock A Mailbox Down When You Were A Teen And Were Charged With A Felony You May Want To Appeal, But If You Were Convicted Of Larceny In New York You May Not To Appeal. Our Gate Are A Level Of Protection But We Open Them To Anyone Who Has A Reservation.
